The regular monthly meeting of the Council of R.M.No,463, of Duck Lake, was held in the Town Hall council Chambers, on the 6th day of february, 1915.

All members being present, the minutes of previous meeting were read by the Sec'y and adopted, motion by Coun Blakeney. Carried.

The matter of providing funds for the Meridian S.D.No, 2295, was again brought to the attention of the council, the question of granting an advance to the said district was fully discussed. The Sec'y was instructed to write to the Sec'y of the Meridian S.D. informing

Moved by Reeve Craig that the following councillors be authorized to expend the following amounts in their respective Divisions, viz., Div, No, (1) \$50.00 Div, No, (2) \$100. Div, No, (3) \$50.00 Div, No, (6) \$50. said amounts to be expended in road work. Carried.

The following ratepayers were recommended as weed inspectors, by the councillors of the divisions concerned and were appointed by the council on a motion by Coun Blakeney, the latter suggesting that only one Weed Inspector be appointed for each two divisions of this R.M..Car Div, (1 & 2) Mr J. Bonthoux, Jr, Titanic, P.O. Divs (3 & 6) M.Hall, Lily Plain, P.O. Div, (4 & 5) Mr Wm Denney, Wingard, P.O.

The committee appointed to investigate the matter of Wm Tabaschnuk Hospital Bill reported the following, viz, WE BEG TO REPORT TO THIS COUNCIL THAT WE HAVE FULLY INVESTIGATED THE CASE OF MR TABASCHNUK'S HOSPITAL BILL AND HAVE FOUND THAT SAID GENTLEMAN IS ABLE TO PAY HIS OWN BILL. Moved by Reeve Craig that Weed Inspectors be allowed the following number of days (in their respective territory) at \$5.00 per day while inspecting, viz, Div (1&2) nine days. Div (4 & 5) five days. Div (3 & 6) six days. Motion carried.

Moved by Coun H.C.Pocha that the following Poundkeepers (pounds at their respective places) be appointed, viz, Div(1) Fr Vernerey, Div(2) Gustave Mandin, Div, (3) Eug Tate, Div, (4) Alb Bell, Div(5) t.Saworski, Div, (6) A.K.Woodhouse. Motion carried.
